

AGREEMENT, RELEASE AND WAIVER OF LIABILITY

In consideration of the opportunity to participate in the above referenced event, I, individually and on behalf of my heirs, personal representatives, successors and assigns agree as follows:

I am experienced in and familiar with the risks and dangers inherent in motorcycling. I am over the age of 18.

I understand and acknowledge that participation in Events or activities involving motorcycles and motor vehicles may be dangerous and involve risks which include, but are not limited to, property damage, bodily injury, partial or total disability, paralysis and death. I also understand and acknowledge that the social and economic losses or damages which can result from those risks and dangers can be severe and that not all such risks and dangers may be known or reasonably foreseeable.

I agree to take appropriate precautions for my own safety and that of others when participating in the program and further agree that, before participating, I will inspect my motorcycle or vehicle to ensure that it is mechanically sound and fit for the purpose which it will be used. During the pendency of the EVENT I will Follow all safety instructions given to me by the SPONSOR, or Officers, Agents or designee's, and all guidelines set out by the Sponsor. If I should observe anything unsafe, I will immediately advise an agent, designee, employee or volunteer, if it is safe to do so, and will refuse to participate if the unsafe condition becomes a threat to my well being or that of others.

I further agree that, before participating, I will obtain, and maintain during the pendency of the EVENT. A policy of liability insurance to protect against person or property damage.

I am voluntarily participating in the EVENT and I expressly agree to assume the entire risk of any collisions, accidents or personal injury, including death, sustained to my person and/or property as a result of my participation in the EVENT and the risk of injury or damages sustained on account of any negligence (except willful negligence) on the part of the SPONSOR or any of it's officers, agents, designees, employees or volunteers (herein "RELEASED PARTIES").

I hereby release, waive and discharge RELEASED PARTIES and all others acting on their behalf, from liability to me, my legal representatives, spouse, assigns, heirs, and next of kin from any and all claims and demands, losses or damages account of any injury, death, or damage to property, rights and causes of action of any kind whatsoever, known and unknown, which I now have or later may have against RELEASED PARTIES in any way resulting from, arising out of, or in any way connected to my participation in or at the EVENT.

I also hereby agree to indemnify and hold harmless from any claim or demand RELEASED PARTIES and all others acting on their behalf from any claim or damage on account of injury or damage which I may suffer as a result of participation at or in the EVENT.

This release extends to any and all claims I have now or may have later against the released parties and all others acting on their behalf, resulting or arising out of my participation in the EVENT, whether or not such claims result from negligence (except willful neglect) on the part of any or all of THE RELEASED PARTIES and all others acting on their behalf with respect to the EVENT or with respect to the conditions, qualifications, instructions, rules or procedures under which the EVENT is conducted or from any other cause.

I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES AND THOSE ACTING ON THEIR BEHALF FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY FROM OR IN CONNECTION WITH THEIR SPONSORING, PLANNING, OR CONDUCTING THE EVENT.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from any state statute which would negate or limit the scope of this Release and Indemnification agreement.

By signing the release, I certify that I have read this release and waiver of liability and fully understand it and understand that by signing it I have given up substantial rights, that I'm not relying on any statements or representations made by the RELEASED PARTIES and that I signed this agreement voluntarily.
